BBIA Steering Committee Officers and Duties

Adopted by the BBIA Steering Committee on December 6, 2023

The Chair, shall:

- Serve as the Chair of the Executive Committee
- Be responsible for the operation of the BBIA and its officers pursuant to the bylaws
- Prepare the agendas of meetings of the Steering Committee and the General Membership,
- Preside at the meetings of the Steering Committee and the General Membership,
- Serve as the primary liaison with the County, State, and Boundary Review Board
- Act as a signature on checks and bank records
- Serve as an ex-officio member of all BBIA Working Committees

The Vice-Chair, shall:

- Assist the Chair in planning and conducting meetings,
- Schedule meeting facilities,
- Assume the duties of Chair when the Chair is unavailable
- Perform other duties assigned by the Steering Committee
- Serve on the Executive Committee

The Secretary, shall:

- Maintain written records and files for the BBIA (Matt)
- Maintain the BBIA membership list,
- Prepare sign-in sheets for each BBIA meeting and maintain records of meeting attendance,
- Prepare minutes of meetings
- Provide records for paper or electronic publication as directed by the Steering Committee
- Serve on the Executive Committee

The Treasurer, shall:

- Serve as Chair of the Finance Committee
- Prepare a budget for the BBIA
- Maintain all financial records for the BBIA,
- Collect all monies due or donated and deposit them in the BBIA bank account
- Act as a signature on checks and bank records
- Maintain an accurate accounting of all expenditures of the BBIA,
- Present financial reports at meetings of the Steering Committee and general membership

- Provide financial records as necessary for compliance with any governmental agency required filings
